Please see attached details of the keywords recorded for complaints (investigated) about Northumbria Healthcare NHS Foundation Trust (the Trust). These keywords will give you a general idea of the nature of the complaints we investigated but will not necessarily provide a full understanding of the issues complained about. Which

can be complex and span a number of areas.

I am unable to provide you with more specific details relating to the nature of the complaints. This is because the Ombudsman's legislation (the Health Service Commissioners Act 1993) specifies that investigations must be conducted in private (S11)(2) and that information obtained for the purpose of an investigation may only be disclosed in certain circumstances as set out in Section 15(1)(a).

Section 44 of the Freedom of Information Act 2000 states that information does not have to be disclosed if another Act of Parliament states that the information cannot be disclosed. This means we cannot provide it under Freedom of Information law.

You may be interested to know that we do publish summaries of investigations on our website. I have searched for complaints about the Trust and we do not appear to have published any to date. However, you may wish to check again at a later date.


