## Re: Staff grrievances

Thank you for your request received on 16 January 2019 addressed to Public Health England (PHE). In accordance with Section 1(1)(a) of the Freedom of Information Act 2000 (the Act) I can confirm that PHE holds the information you have specified.

You asked:

1. Please advise for each of the years

2018/19 year to date 2017/18 2016/17 2015/16 2014/15 2013/14

1. How many grievances were lodged by PHE staff?

PHE has only recently begun recording a detailed year on year analysis of its grievances held since 2016/17 and therefore data is only available from this time.

2018/19 year to date = 17 2017/18 = 31 2016/17 = 30 2. For the total number of grievances in the period 2013/14 to 2018/19 year to date, please advise how many of the grievances were upheld.

For the years that we hold data the number of grievances upheld were:

In 2016/17 30 grievances were received of which:

- 1 grievance individual fully upheld
- 1 grievance individual partially upheld

In 2017/18 31 grievances were received of which:

- 1 grievance – individual - partially upheld

In 2018/19 to date 17 grievances have been received of which:

- 1 grievance bullying and harassment partially upheld
