Tim Kelsey – National Information Director Chair, National Information Board

Biography

Tim Kelsey is National Director for Patients and Information in NHS England - a role which combines the functions of chief technology and information officer with responsibility for patient and public participation. He took up the post in 2012 after serving as the British government's first Executive Director of Transparency and Open Data.

He is also National Information Director for health and care in England and Chair of the National Information Board which advises the Secretary of State on national priorities for data and technology.

Tim was co-founder of Dr Foster in 2002, a company which pioneered publication of patient outcomes in healthcare. In 2007, he launched NHS Choices, the national online health information service.

Before Dr Foster, Tim was a national newspaper journalist and a television reporter.

David Behan - Chief Executive, Care Quality Commission

Biography

David Behan was awarded a CBE in 2003, and, in 2004, was awarded an Honorary Doctorate in Law by Greenwich University.

He was previously the Director General of Social Care, Local Government and Care Partnerships at the Department of Health, the President of the Association of Directors of Social Services, and the first Chief Inspector of the Commission for Social Care Inspection.

From 1996 to 2003, David was Director of Social Services at London Borough of Greenwich as well as a member of the Greenwich Primary Care Trust Board and the Professional Executive Committee

Emma Rourke - Director of Intelligence, Care Quality Commission

Biography

Emma Rourke is responsible for the Commission's approach to using information in regulation including all aspects of analysis and information management. Emma is also responsible for the CQC Knowledge and Information Strategy 'An intelligence-driven CQC'.

Her career began in nursing people with learning disabilities and mental health issues before roles in NHS management across both primary and acute secondary care. Emma joined the CQC's ancestor, the Healthcare Commission in 2005 where she was responsible for the development of performance indicators against which NHS trusts were held to account as part of their annual rating. Since CQC was created, Emma has held both policy and intelligence positions, taking up her current post in August 2013.

Andy Williams - Chief Executive, Health and Social Care Information Centre

Biography

Andy Williams has extensive experience in overseeing large transformational technology projects in the UK and around the world having led teams in companies such as IBM, Alcatel-Lucent and CSC.

He has worked across a variety of industry sectors, usually being involved in programme governance, introducing complex new technology and managing change.

lan Cumming – Chief Executive, Health Education England

Biography

Ian has held a variety of NHS senior management posts, including Operating Theatre Manager at a large teaching hospital and Assistant Chief Executive to the former North West Regional Health Authority, before spending the last 16 years in CEO roles in the NHS. When Ian was first appointment as CEO in 1995, he was the youngest ever Chief Executive in the NHS.

In 2006, after almost 12 years as the CEO of a group of teaching hospitals, Ian was appointed CEO of NHS North Lancashire, a NHS commissioning body.

From 2009 until 2011, Ian was CEO of NHS West Midlands – one of ten regional Strategic Health Authorities for the NHS in England. On taking up this role Ian also became a member of the national Management Board for the NHS in England. NHS West Midlands looked after the health needs of a population of approximately 5.5million and expended almost £10bn per annum.

Ian was previously the National Director of Quality during Transition for the NHS in England.

Steve Clarke – Director of Finance, Health Education England

Biography

Steve Clarke was Director of Finance for NHS Midlands and East and for NHS East of England since its inception in 2006. He was previously Director of Finance & Performance for Trent SHA.

Dr Janet Wisely – Chief Executive, Health Research Authority

Biography

Janet Wisely obtained a PhD in Physics from the University of London, joined the NHS in 1992 and has spent her entire working career associated with research and the NHS. Janet is an innovative leader with a track record of successful change management who, as the Director of the National Research Ethics Service, has transformed the UK ethics service into an internationally recognised system for ethical review. She has also been instrumental in delivering wider change through the provision of the Integrated Research Application System which streamlines the application processes for researchers. As Chief Executive of the Health Research Authority, Janet is leading work to further improve the environment for research to make it easier to do good quality, ethical research in the UK. Janet is an honorary fellow of the faculty of pharmaceutical medicine and in July 2013 was selected onto the inaugural HSJ Inspirational Women list.

Stephen Robinson – Corporate Secretary, Health Research Authority

He also started the NHS Direct service in Essex and developed that into a national pathfinder site. He later gained an interest in broader health service management, so moved to a Health Authority and then onto Southend PCT where he was responsible for corporate governance, strategic/business planning, information technology and performance management. Using this experience and knowledge Stephen set up his own consultancy, which specialised in managing change and developing services in both the public and private sectors, such as various PCTs, Kent Community Health NHS Trust and CAPITA.

He has been with the Health Research Authority for 2 years and as Corporate Secretary supports the Board and the Executive Team in areas such as governance, risk management, health & safety, information governance and equality and diversity.

Peter Thompson – Chief Executive, Human Fertilisation and Embryology Authority

Biography

Before joining the Human Fertilisation and Embryology Authority (HFEA), Peter worked as a civil servant for a number of Government departments, including the Ministry of Justice and the Cabinet Office. Among a variety of roles, Peter was responsible for the Government's policy on the legal recognition of transsexual people, EU justice policy and the Prime Minister's programme of constitutional renewal.

As Chief Executive, Peter is responsible for the overall performance of the HFEA. Peter believes that the HFEA should focus its work around encouraging high quality care and providing patients with the information they need to make effective choices.

Peter is also a School Governor in an inner city secondary in East London.

Nick Jones – Director of Compliance and Information

Biography

Nick joined the Human Fertilisation and Embryology Authority in 2010. Prior to this he worked at the Care Quality Commission and in healthcare regulation (within the Commission and its predecessor bodies) since 2002.

As Director of Compliance & Information he is accountable for ensuring that all licensed centres (IVF clinics and centres undertaking embryo research) comply with the requirements of the Human Fertility and Embryology Act. This encompasses delivery of inspections, the holding of the 'Register' and applications from people who wish to find out about their genetic inheritance, how clinics submit data to the HFEA, the investigation of incidents in clinics and more.

He leads the Authority's *Information for Quality* programme to transform the way the HFEA collects, processes and publishes information. The programme is aligned to the ambitions of the NIB framework and will ensure the assisted reproduction sector benefits from the ambitions for the rest of the system. The HFEA has just concluded a consultation with patients, clinics and other stakeholders on the programme – and with over 400 responses is well placed to transform the way clinics submit information to reduce the burden on them; to enable them to spend more time with

patients; and for the HFEA itself to put the information it holds to much greater benefit for all – all happening in 2015.

Nick strongly believes that regulation can play an important role in partnership with people who use and provide services to bring about improvements in the quality of care and patient safety: regulation as catalyst.

Alan Clamp – Chief Executive, Human Tissue Authority

Biography

Alan Clamp joined the Human Tissue Authority (HTA) in January 2011, with responsibility for all licensing and regulatory activities to promote confidence in the safe and ethical use of human tissues and organs.

Alan holds a degree in Natural Sciences, an MBA and a PhD in Clinical Biochemistry, and has considerable experience in the field of regulation as an inspector and as a senior manager. He has also managed successfully significant organisational change in national public sector organisations.

As the Chief Executive of the HTA, Alan is the Accounting Officer and is responsible for implementing the strategic plan of the organisation. This involves improving the efficiency and effectiveness of regulation, ensuring that the HTA has appropriate and productive relationships with its stakeholders, and leading and managing the skilled and dedicated workforce at the HTA. Alan is also responsible for ensuring that the HTA is governed effectively and provides good value for money.

Allan Marriott-Smith - Director of Strategy and Quality, Human Tissue Authority

Biography

Allan Marriott-Smith joined the Human Tissue Authority (HTA) in May 2009, prior to which he had worked for a number of years as a government statistician -most recently at the UK Statistics Authority.

At the HTA, Allan has corporate responsibility for the strategic and business planning process - working with the Authority to undertake its annual strategy review and ensuring that the strategy translates into effective business plans, supported by a robust performance management system. Dr Ian Hudson – Chief Executive, Medicines and Healthcare products Regulatory Agency

Biography

Dr Hudson is a physician who practised as a paediatrician for a number of years, before working in the pharmaceutical industry in clinical research and development between 1989 and 2001, when he joined the former Medicines Control Agency (MCA) as Director of the Licensing Division.

Before being appointed as Chief Executive, Dr Hudson was the Medicines and Healthcare products Regulatory Agency's (MHRA) Licensing Director, responsible for the majority of its medicines licensing activities. He was also the UK delegate to the Committee for Human Medicinal Products (CHMP) and was its vice-chairman from October 2012 to September 2013.

Dr Janet Valentine – Director of Clinical Practice Datalink, Medicines and Healthcare products Regulatory Agency

Biography

Dr Janet Valentine joined the Clinical Practice Research Datalink as Director in January 2015 having been Head of Population Health and Informatics at the Medical Research Council (MRC) since 2008. His work on blood transfusion won the 2012 HSJ Award for "Improving Care with Technology" and the 2012 National Patient Safety Award for "Technology and IT to improve Patient Safety". In 2014 he became one of the HSJ's "100 Clinical Leaders".

He is a Board Member with responsibility for patient liaison of "Lab Tests Online UK", which tells patients about laboratory investigations.

Professor Kay enjoys human powered vehicles, driving the Caterham 7 which he built, and acting with the Oxford Theatre Guild, Holton Players and Garsington Players.

David Flory CBE – Chief Executive, NHS Trust Development Authority

Biography

David Flory is the Chief Executive of the NHS Trust Development Authority (NHS TDA) which came into being in June 2012 with the purpose of delivering the Department of Health's Foundation Trust pipeline objective. The NHS TDA took on its full range of powers and responsibilities in April 2013.

Dame Fiona Caldicott is the Chair of the Oxford University Hospitals NHS Trust and was appointed Chair of the Independent Information Governance Oversight Panel in June 2011.
