Thank you for your request for information.

Your Request & Our Response

1) All pieces of work and projects that the trust has commissioned from the company TheValueCircle LLP Company Number OC419158

From 19/20 the Trust commissioned 3 pieces of work:-

- a review of our Wholly Owned Subsidiary Atlas
- a review of our Divisional Structure and consideration of a Tertiary Division
- a support piece of work for the Development of the Provider Collaborative for L&SC this was commissioned by BTH but was for the entire PCB across Lancashire and South Cumbria.

Prior to this data is not readily available and would require a disproportionate effort to retrieve which would exceed 18 hours. This information is therefore exempt on the grounds of cost (Section 12(1)).

2) Total spending on TheValueCircle's services and products to date

The total costs of the 3 projects was £350K

3) Which consultants supplied by TheValueCircle have undertaken the work for the trust

David Cockayne, Chief Executive of Value Circle, was the lead contact for the projects, deploying various other consultants dependent upon the work.
