## Section 10 FOIA failure and false claims by Sandwell and West Birmingham NHS Trust FOI Request ref: F23/0023

I requested information from Sandwell and West Birmingham NHS Trust about services and products purchased from a private company, called "TheValueCircle" on 7 April 2023.

On 13 April 2023 the trust claimed it had "never" purchased any service from this company:

"We have never commissioned this company for any consultancy work, advice or any services."

I sent the trust the excerpt from its own trust board papers disproving this.

The FOI department ignored this.

Please see the relevant correspondence forwarded below.

In the meantime I wrote to the Trust Chair David Nicholson who had reportedly commissioned a report from TheValueCircle, to ask him if he had prior experience of the company or received a recommendation.

His office informed me on 18 April 2023:

"Sir David has confirmed that he has not used The Value Circle previously. Sandwell and West Birmingham used them and I understand that they produced a good report which focussed heavily on the culture and behaviour elements of governance. This was requested by Richard Beeken the CEO. There is no connection with NHSE."

This reply covers some of the elements of my FOI request but not all. I will also forward this correspondence from David Nicholson's office.

I would like a proper reply to my FOI request of 7 April 2023.

I note the variance between published board minutes and the Chair's current account of events as regards who actually commissioned the report by TheValueCircle.

The activities of TheValueCircle are currently a matter of intense public interest because they have been given the commission for a culture review at University Hospitals Birmingham NHS Foundation Trust due to a scandal following a BBC Newsnight investigation.

FOI requests show a pattern of questionable spending on this company by other NHS trust boards, with little accountability for large sums of money spent, and refusals to disclose reports or even claims that no reports existed after six figure sums were spent on TheValueCircle's services.

For example, Walsall Healthcare NHS Trust spent over £119K on consultancy but claimed it held no reports by TheValueCircle to show for this. Walsall Healthcare is another trust chaired by David Nicholson. This is the relevant FOI disclosure by Walsall Healthcare:

- 1. The Trust strategy and objectives were they clear and being utilised
- 2. Governance structures how effective the meetings were, whether there was learning
- 3. Executive portfolios and alignment
- 4. Governance processes quality, corporate in terms of risk, policy compliance, freedom to speak

up, information governance

- 5. Line of sight from Ward to Board as well as linkages across the organisation
- 6. Evidence view on level of staff and patient engagement, learning in the organisation
- 7. Risks identified, escalated, tracked and managed
- 8. Any additional areas identified ahead of or during the assessment process.

A comprehensive view would be important as the driving force behind deciding how to set the

organisation up for success post-COVID. He thanked everyone for the work they would be doing to help

make this a reality over the next few months."
